

Sweepstakes Official Rules & Regulations

The Radio Flyer Fly to School Sweepstakes

NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. **Sponsor:** The Radio Flyer Fly to School Sweepstakes (the "Sweepstakes") is sponsored by Radio Flyer Inc. (the "Sponsor").
2. **Official Rules:** These are the official rules (the "Official Rules") for the Sweepstakes. By entering any of the Sweepstakes, Entrants agree that they can be contacted by phone or email regarding the Sweepstakes, and to be bound by these Official Rules and all decisions of the Sponsor relating to the Sweepstakes, which shall be final and binding on Entrants.
3. **Sweepstakes Period:** The Sweepstakes is a multiple day sweepstakes in which one (1) eligible Entrant will be awarded the partnership prize bundle (as described in more detail below). Sweepstakes will commence at 5:00 p.m Central Standard Time ("CST") on August 2, 2022, and end at 5:00 p.m. CST on August 12, 2022 (the "Sweepstakes Period"). All entries received during the Sweepstakes Period are eligible for the random drawing. Sponsor reserves the right to modify, extend, suspend or terminate the Sweepstakes in its sole discretion with or without cause. Sponsor's computer is the official clock for the Sweepstakes.
4. **Eligibility:** The Sweepstakes is open to legal residents of the 50 United States of America and District of Columbia (excluding residents of the Province of Quebec) who are 18 years of age or older, or the age or majority in the jurisdiction in which they reside, whichever is older, at the time of entry. The Sweepstakes is not open to employees of Sponsor, or of its parent companies, affiliates, subsidiaries, and advertising or promotional agencies(collectively the "Sweepstakes Entities"), or to the immediate family members of, or to any persons domiciled with, any such employees. For purposes of the Sweepstakes, "immediate family members" include a participant's spouse, children, siblings, parents, grandparents and grandchildren. Void in any state or province not listed above and where prohibited by law, rule, or regulation. All federal, state and local laws and regulations apply.
5. **How to Enter: Sweepstakes Entry is through Instagram. NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN.**

Instagram Entry: Entrants may enter the Sweepstakes through Instagram. To enter, you must have or create a public Instagram account and a device that supports the Instagram app. You can become an Entrant by (1) following all partner brands **@radioflyerinc @outdoorschoolshop @highlightsforchildren**; and (2) tagging a friend in the comments on the Radio Flyer Instagram Page ("Entry Requirements"). Any entry that is submitted without following the Entry Requirements will not be considered for the Grand Prize.

By entering via a third party social network site, you are authorizing Sponsor to access and utilize portions of your social network site information. Sponsor reserves the right, at any time and for any reason or for no reason, to disassociate any person from its social media network page/following by any means then technically available to it (for example, "blocking" your account from liking or following Sponsor's account).

Entrant acknowledges that Sponsor cannot control certain factors relating to use of the Instagram platform, including, without limitation, errors, cancellation of accounts or technical malfunctions that may affect any Entrant's ability to enter, win, view, be advised of, be eligible for or be properly considered in the Sweepstakes. Multiple Entrants are not permitted to share the same email address or Instagram account. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different Instagram accounts, email addresses, identities, registrations and logins, or any other methods will void that Entrant's Entry and that Entrant may be disqualified. Each potential winner may be required to show proof of being an authorized account holder. In the event of a dispute regarding the identity of a User, a person who can demonstrate the ability to log into the applicable account with the correct user name and password will be deemed the User who submitted the entry. Sponsor may message Entrant via Instagram direct message to obtain email address for verification. Instagram is not a sponsor, does not endorse, and is in no way affiliated with the Sweepstakes.

NOTE ABOUT MOBILE: If Entrant opts to participate in this Sweepstakes via Instagram, the Sweepstakes must be via Entrant's wireless mobile device (which may only be available via participating wireless carriers and is not required to enter), standard text messaging rates or data charges may apply for each text message or data sent or received from Entrant's handset according to the terms and conditions of Entrant's service agreement with Entrant's wireless carrier. Other charges may apply (such as normal airtime, data charges and carrier charges) and may appear on Entrant's mobile phone bill or be deducted from Entrant's prepaid account balance. 6. **Determination of the winner:** Sponsor will conduct one (1) random prize drawing from all eligible entries received during the Sweepstakes Period on the Radio Flyer Instagram Page. One (1) grand prize winner will be randomly selected. A Provisional Winner will be selected on or about ten (10) days after the end of the drawing (the "Drawing Date"). The Provisional Winner will be notified by Instagram Direct Message and will need to provide a telephone number or email address in order to be contacted to confirm they are the winner. If the Provisional Winner does not respond within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize, Winner's affidavit/release or prize notification as undeliverable will result in disqualification, the forfeiture of all interest in the prize, and selection of a substitute Winner from among all remaining eligible entries. The Winner may be required to provide evidence of identity in connection with claiming the prize. Non-winning entries will not carry forward to or be included in any subsequent sweepstakes or prize drawings of Sponsor.

The approximate retail value of the Grand Prize is **\$2636.88.
