

Sweepstakes Official Rules & Regulations

International Women's Day eBike Social Media Giveaway Sweepstakes

1. **NO PURCHASE, PAYMENT, OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Sponsor:** The Radio Flyer International Women's Day eBike Social Media Giveaway Sweepstakes (the "Sweepstakes") is sponsored by Radio Flyer Inc. (the "Sponsor").
3. **Official Rules:** These are the official rules (the "Official Rules") for the Sweepstakes. By entering any of the Sweepstakes, Entrants agree that they can be contacted by phone or email regarding the Sweepstakes, and to be bound by these Official Rules and all decisions of the Sponsor relating to the Sweepstakes, which shall be final and binding on entrants.
4. **Sweepstakes Period:** The Sweepstakes is a single day sweepstakes in which one (1) eligible Entrant will be awarded two (2) Flyer eBikes of their choice (as described in more detail below). Sweepstakes will commence at 9 a.m. Central Standard Time ("CST") on 3/8/2022, and end at 11:59 p.m. CST on 3/8/2022 (the "Sweepstakes Period"). All entries received during the Sweepstakes Period are eligible for the random drawing. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes in its sole discretion with or without cause. Sponsor's computer is the official clock for the Sweepstakes.
5. **Eligibility:** The Sweepstakes is open to legal residents of the 50 United States of America and District of Columbia and Canada (excluding residents of the Province of Quebec) who are 18 years of age or older, or the age or majority in the jurisdiction in which they reside, whichever is older, at the time of entry. The Sweepstakes is not open to employees of Sponsor, or of its parent companies, affiliates, subsidiaries, and advertising or promotional agencies (collectively the "Sweepstakes Entities"), or to the immediate family members of, or to any persons domiciled with, any such employees. For purposes of the Sweepstakes, "immediate family members" include a participant's spouse, children, siblings, parents, grandparents and grandchildren. Void in any state or province not listed above and where prohibited by law, rule, or regulation. All federal, state and local laws and regulations apply.
6. **How to Enter:** There is one method of Entry for this Sweepstakes. **NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN.** To enter, you must have or create an Instagram account. Membership on Instagram is free. Entrants will visit Sponsor's Instagram page, follow @RadioFlyerInc on Instagram, and post a comment on a specific Instagram post. Entrants will automatically receive one Entry into the Sweepstakes by this method of Entry. One (1) bonus entry per entrant possible by reposting Sponsor's International Women's Day eBike Giveaway Instagram news feed post to entrant's Instagram Story on their public Instagram account. Only public Instagram accounts are eligible for Instagram Stories bonus entries.

Instagram Entry: Entrants may enter through Instagram. To enter, you must have or create a public Instagram account and a device that supports the Instagram app. After you have established your Instagram account, locate @RadioFlyerInc Instagram page during the Sweepstakes Period. You can become an Entrant by following @RadioFlyerInc on Instagram and @mention a friend in the comments under Sponsor's International Women's Day eBike Giveaway Instagram news feed post, which will publish on 3/8/2022. - contains materials identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission;
- and/or violates any law.

Instagram is not a sponsor, does not endorse, and is in no way affiliated with the Sweepstakes. All entries become the property of Sponsor and will not be acknowledged or returned. Sponsor is not liable for entries that are lost, late, misdirected, incomplete, garbled, incompletely received, mutilated, or illegible, for any reason.

7. **Limits:** There is a limit of 15 entries per Entrant for the entire Sweepstakes Period. All Entries become the property of Sponsor and will not be acknowledged or returned.
8. **Determination of the winner:** Sponsor will conduct one (1) random prize drawing from all eligible entries received during the Sweepstakes Period. One (1) grand prize Provisional Winner will be randomly selected. A Provisional Winner will be selected on or about ten (10) days after the end of the drawing (the "Drawing Date"). The Provisional Winner will be notified by Instagram Direct Message and will need to provide a telephone number or email address in order to be contacted to confirm they are the winner. If the Provisional Winner does not respond within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance

with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize, Winner's affidavit/release or prize notification as undeliverable will result in disqualification, the forfeiture of all interest in the prize, and selection of a substitute Winner from among all remaining eligible entries. The Winner may be required to provide evidence of identity in connection with claiming the prize. Non-winning entries will not carry forward to or be included in any subsequent sweepstakes or prize drawings of Sponsor.

The retail value of the Flyer™ L885 is \$1,999.00 and the retail value of the Flyer™ M880 is \$1,799.00. **The odds of winning the grand prize depend on the number of eligible entries entered into the random draw pool for the Sweepstakes Period.** The prize will be shipped at no cost to Winner to the address provided by Winner when Winner claims the Grand Prize. Expect 1 to 2 weeks for delivery.
