

Sweepstakes Official Rules & Regulations

#CampRadioFlyer Photo Sweepstakes

1. **NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Sponsor:** The Radio Flyer #CampRadioFlyer Sweepstakes (the “Sweepstakes”) is sponsored by Radio Flyer Inc. (the “Sponsor”).
3. **Official Rules:** These are the official rules (the “Official Rules”) for the Sweepstakes. By entering any of the Sweepstakes, Entrants agree that they can be contacted by phone or email regarding the Sweepstakes, and to be bound by these Official Rules and all decisions of the Sponsor relating to the Sweepstakes, which shall be final and binding on entrants.

Sweepstakes will commence at 12:00 a.m Central Standard Time (“CST”) on July 27, 2020 and end at 11:59 p.m. CST on July 31, 2020 (the “Sweepstakes Period”). All entries received during the Sweepstakes Period are eligible for the random drawing. Sponsor reserves the right to modify, extend, suspend or terminate the Sweepstakes in its sole discretion with or without cause. Sponsor’s computer is the official clock for the Sweepstakes.
5. **Eligibility:** The Sweepstakes is open to legal residents of the 50 United States of America and District of Columbia and Canada (excluding residents of the Province of Quebec) who are 18 years of age or older, or the age or majority in the jurisdiction in which they reside, whichever is older, at the time of entry. To enter via this method, you must access the RadioFlyer.com webpage below. Entrants must find the "Add Your Photo" uploader. Entrants can click the uploader to share their photo to the website.

Entries may not contain, as determined by the Sponsor, in its sole discretion, any response or comment that:

- is sexually explicit or suggestive, violent, or derogatory of any ethnicity, race, gender, religion, profession, or age group, or is profane or pornographic;

- is obscene or offensive, or endorses any form of hate or hate group;

Limits: There is a limit of 30 entries per Entrant for the entire Sweepstakes Period. All Entries become the property of Sponsor and will not be acknowledged or returned.

7. **Determination of the winner:** Sponsor will conduct one (1) random prize drawing from all eligible entries received during the Sweepstakes Period. One (1) grand prize winner will be randomly selected. A Provisional Winner will be selected on or about ten (10) days after the end of the drawing (the "Drawing Date"). The Provisional Winner will be notified by Twitter or Instagram Direct Message and will need to provide a telephone number or email address in order to be contacted to confirm they are the winner. If the Provisional Winner does not respond within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize, Winner's affidavit/release or prize notification as undeliverable will result in disqualification, the forfeiture of all interest in the prize, and selection of a substitute Winner from among all remaining eligible entries. Expect 1 to 2 weeks for the gift card to be provided. 13. **Additional Entrant Obligations:** Each Entrant agrees that he/she shall not upload, post or transmit any materials to the Sponsor website which contain any computer viruses, Easter eggs, worms, Trojan horses or other harmful component or programming routines that are intended to damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or personal information.
14. **Disqualification:** Sponsor reserves the right to disqualify any Entrant found tampering with the entry process or with the operation of the Sweepstakes, who commits any fraud in relation to the Sweepstakes, or who violates these Official Rules. **Caution: any attempt by an Entrant to deliberately damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and will result in disqualification of such Entrant. Should such an attempt be made, Sponsor reserves the right to seek remedies and damages (including attorneys' fees) from any such participant to the fullest extent of the law, including criminal prosecution.**
